

2. EXCHANGE OF STUDENTS AND FACULTY MEMBERS:


A. Reciprocal arrangement based on mutually acceptable terms shall be accomplished to give an impetus to improve education.

b. The parties to this memorandum may, by mutual consent, add modify, amend, delete, review or revise and term(s) and condition(s) of this agreement.


